### e-tender Notice

(e-tender notice for the Transportation of commercial printed materials)

- E tenders are invited through <u>www.etenders.kerala.gov.in</u> for the safe **transportation** and delivery of commercial printed materials to various destinations all over Kerala for a period of one year. Interested parties are requested to quote their rates (exclusive of all taxes and levies) towards the following specifications as per the terms and conditions and type of vehicles/ various capacities as detailed below.
  - "Up and down distance per Km basis (From KBPS to delivery point and return back to KBPS"
  - 2. "Rate for one side distance up to destination per Km basis (Farthest distance from KBPS will be considered as last point of delivery)"

## Terms and conditions:

- 1) All tenders/bid shall be accepted only through online mode. (https://etenders.kerala.gov.in) and no manual submission of the same shall be allowed.
- 2) Re submission of offer is possible, before the last date as permitted in the site.
- 3) The rates should be quoted only in BOQ, rates quoted elsewhere will not be considered. The offer should be valid for the entire contract period.
- 4) The rate (exclusive of all taxes and levies) should be quoted per kilometer basis as per the following slab for each capacity vehicle.
  - 1. Up to 50 Km (Minimum Charge)
  - 2. Additional rate per Km.

# Capacity of vehicle

- a) Up to 2 MT
- b) Above 2 MT to 3 MT
- c) Above 3MT to 5 MT
- d) Above 5 MT to 8MT
- e) Above 8 MT to 10 MT
- f) Above 10 MT [If weight exceeds 10 MT, then extra charge will be paid]

- 5) Loading from KBPS will be arranged by us. Unloading charges at various delivery points have to be borne by the contractors and will be reimbursed on presentation of the actual bills. The delivery challans duly stamped and signed by the consignee should be brought back and submitted immediately.
- 6) The vehicle should be made available to us immediately as and when required. The contents should be delivered to customers without delay and acknowledgement should be produced along with the bills.
- 7) The due date of the receipt of the e-tender is up to 11 am on 4.8.2025.
- 8) The e-tenders will be opened at 11:30 am on 2 . 8.2025, in presence of parties/representatives who may be present at the time.
- 9) The scanned copy of PAN, GST certificate shall be submitted online, else the tender/bid will be considered invalid. Applicable Declaration regarding income tax should be submitted in letter head.
- 10) Parties/contractors who have defaulted in executing purchase order/contract with KBPS or whose purchase order/contract was terminated by KBPS are not eligible to participate in this tender.
- 11) The near relatives of employees of KBPS are not eligible to participate in this tender. The relationship for the purpose will be as specified in the Annexure 21 of Stores Purchase Manual (extract given as Annexure A). In addition to this mother's sister's son/daughter shall also deemed to be a relative. The scanned copy of the declaration (Annexure B) in this regard, duly filled, signed and sealed shall be submitted, without which the tender will be rejected outright.
- 12) EMD for ₹ 5,500 /- should be remitted through online, else the tender/bid will not be considered and will be summarily rejected.
- 13) Tenders/bids received online should have scanned copy of the agreement (as per the specimen enclosed) executed in ₹ 200/- Kerala Stamp Paper, which is duly filled, signed and sealed on all its pages, else it will be summarily rejected.
- 14) In exigency, the contract will be awarded to one or more contractors as per the decision of the Society. The successful party has to execute an agreement in ₹ 200/- Kerala Stamp Paper and also furnish Security Deposit of ₹ 27,500/- by DD in favour of Managing Director, Kerala Books and Publications Society.

15) All the rights to accept or reject whole or part of the tenders without assigning any reason thereof is reserved by the Society. The decision of the Society will be final & binding on the party.

16) All rules/regulations of the tenders shall be in accordance with the Stores Purchase

Manual of Govt. of Kerala.
