- 2. Re submission of offer is possible, before last date as permitted in the site.
- 3. Offers are acceptable only up to 5 pm on .1.3.... .2025
- 4. Opening of e-tender is scheduled at 11.30 a m on 14.11 .2025
- 5. Prices should be quoted for delivery of materials at our stores F.O.R KBPS
- 6. Bidders are requested to quote rates in the price schedule (BOQ) only. The basic rate, GST, Freight charges, taxes/levies, etc should be quoted separately in the respective columns of BOQ. Please do not quote/mention rates anywhere else in the tender other than BOQ.
- 7. For finalizing the tender in order to give purchase order to the successful bidder the performance of the bidder during the previous supplies, if any, will also be considered.
- 8. Payment will be made only after satisfactory supply & installation report received from our concerned department
- 9. The parties are requested to specify their GST no., PAN no. and HSN code of the item.
- 10. The scanned copy of the tender document duly filled, signed and stamped in every page should be submitted online.

13. No further time will be given for submitting the stamp paper and other related

documents /samples after the closing time of tender.
