- 2. Intending parties may submit the quotations for the item strictly in line with the specification prescribed, on their own letter head in attached quotation format.
- 3. Payment will be made only after the satisfactory receipt of the item in good condition. Offers with advance payment request will be rejected outright.
- 4. The requirement is for one year and price should be quoted for delivery of materials at our office as and when informed F.O.R KBPS.
- 5. The parties are requested to specify their GST No., PAN No. and HSN code of the item.
- 6. Last date for the receipt of quotations is at 4.00 pm on 30/12/2025. Late quotations will not be accepted. The quotations will be opened at 3.00 pm on 31/12/2025 in the presence of such of the parties or their authorized representatives who may be present at that time.
- 7. Parties/contractors who have defaulted in executing any purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this Quotation.
- 8. The near relatives of employees of KBPS are not eligible to participate in the quotation. The relationship for the purpose will be as specified in Annexure 21 of Stores Purchase Manual of Kerala (extract given as Annexure A).
