Sealed tenders are invited from interested parties for Rubberisation of the Printing Machine Rollers of Manugraph, Orient X-cel and Goss make web offset machines with shore hardness ranging from 20-35 (Grade Euro Grade D Super Black). We request you to quote your rate for the work per unit area with your terms and conditions before the due date. The rate may be quoted per sq.cm, so as to get the cost for doing the work on a roller on multiplying the rate with length of the roller x diameter in cm. (ie. Total cost = Rate x Length x Dia) .Rate may be quoted exclusive of taxes.


Terms & Conditions:-

- The envelopes sealed in four sides and middle by using lacquer seal containing the quotation should bear the superscription Rubberisation of the Printing Machine Rollers due on 12.01.2026 and should be addressed to the Managing Director, Kerala Books and Publications Society, Kakkanad P.O., Kochi - 30.
- 2. Intending parties may submit the quotations on their own papers.
- 3. The Contract will be for a period of 1 year which can be extended for further period on mutual consent.
- 4. The Payment will be made only after the satisfactory servicing /maintenance of the item.
- 5. The parties are requested to specify their GST no., PAN no. and HSN code of the item.
- 6. Last date for the receipt of quotations is at 5.00 PM on 12.01.2026. Late quotations will not be accepted. The quotations will be opened at 11.00 AM on 13.01.2026 in the presence of such of the parties or their authorised representatives who may be present at that time.
- 7. EMD for ₹ 5,000/- should be remitted in the form of Demand Draft of any Nationalized Bank drawn in favour of Managing Director, Kerala Books and Publications Society, Kakkanad, Kochi-30, along with agreement in Rs. 200/- Kerala stamp paper, as per the attached format.
- 8. The successful tenderer/ tenderers, on receipt of the work order should furnish an amount of five times that of the EMD as Security deposit against work order and should also execute an agreement in 200/- Kerala stamp paper.
- 9. The tenders without agreement, declaration which are duly filled, signed and sealed and EMD will be summarily rejected.
- 10. Parties/contractors who have defaulted in executing any purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this quotation.

- 11. The near relatives of employees of KBPS are not eligible to participate in the quotation. The relationship for the purpose will be as specified in Annexure 21 of Stores Purchase Manual of Kerala (extract given as Annexure A). In addition to this mother's sister's son/daughter shall also deemed to be a relative. The declaration (annexure B) in this regard, duly filled and signed should be submitted with the offer.
- 12. The declaration as per annexure B is incomplete and without sign and seal will be summarily rejected.
- 13. All the rights to accept or reject whole or part of the Quotation without assigning any reason thereof is reserved by KBPS. The decision of KBPS will be final and binding on the party.
