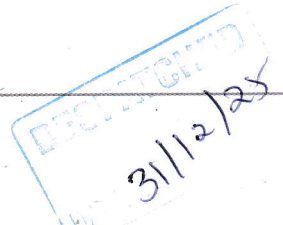

2. Intending parties may submit the quotations on their own letter head.
3. The parties are requested to specify their GST no. PAN no. and HSN code of the item.
4. Last date for receipt of quotations is at 5.00 PM on 15.01.2026 Late quotations will not be accepted. The quotations will be opened at 12.00 P M on 16.01.2026 in the presence of such of the parties or their authorised representatives who may be present at that time.
5. Parties/contractors who have defaulted in executing any purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this Quotation.
6. The near relatives of employees of KBPS are not eligible to participate in the quotation.
