In the Government orders read as 1st and 2nd paper above, it was ordered that the departments of Government and Semi Government Institutions may entrust their work of printing with the Kerala Books and Publications Society without resorting to calling competitive tenders, provided the Superintendent of Government Presses certifies that a particular item of printing work entrusted with him by Government Departments or Semi Government Institutions can not be carried out and printed materials cannot be supplied within two months from the date of receipt of the work order on any sufficient reason. The Managing Director, Kerala Books and Publications Society has now reported that in spite of the standing instructions/Government Orders, Government Departments and Semi Government Institutions are not observing the instructions contained in Government Orders in entrusting their printing work to Kerala Books and Publications Society.

In the circumstances, all the Government Departments and Semi Government Institutions are instructed to entrust their printing work over and above the capacity of Government Presses with Kerala Books and Publications Society without resorting to competitive tenders. The directions contained in the Government Orders read as I, II and III paper above should be strictly be adhered to.
